Taxable Sales

Overview

Cities in DFW generate significant revenue from sales tax, second only to property taxes. The state of Texas levies a **6.25%** sales tax and permits cities to charge an additional tax of up to 2%. Many cities, particularly larger ones like Dallas, allocate 1% to the city's general fund and the remaining 1% to specific purposes like public transit or special districts.

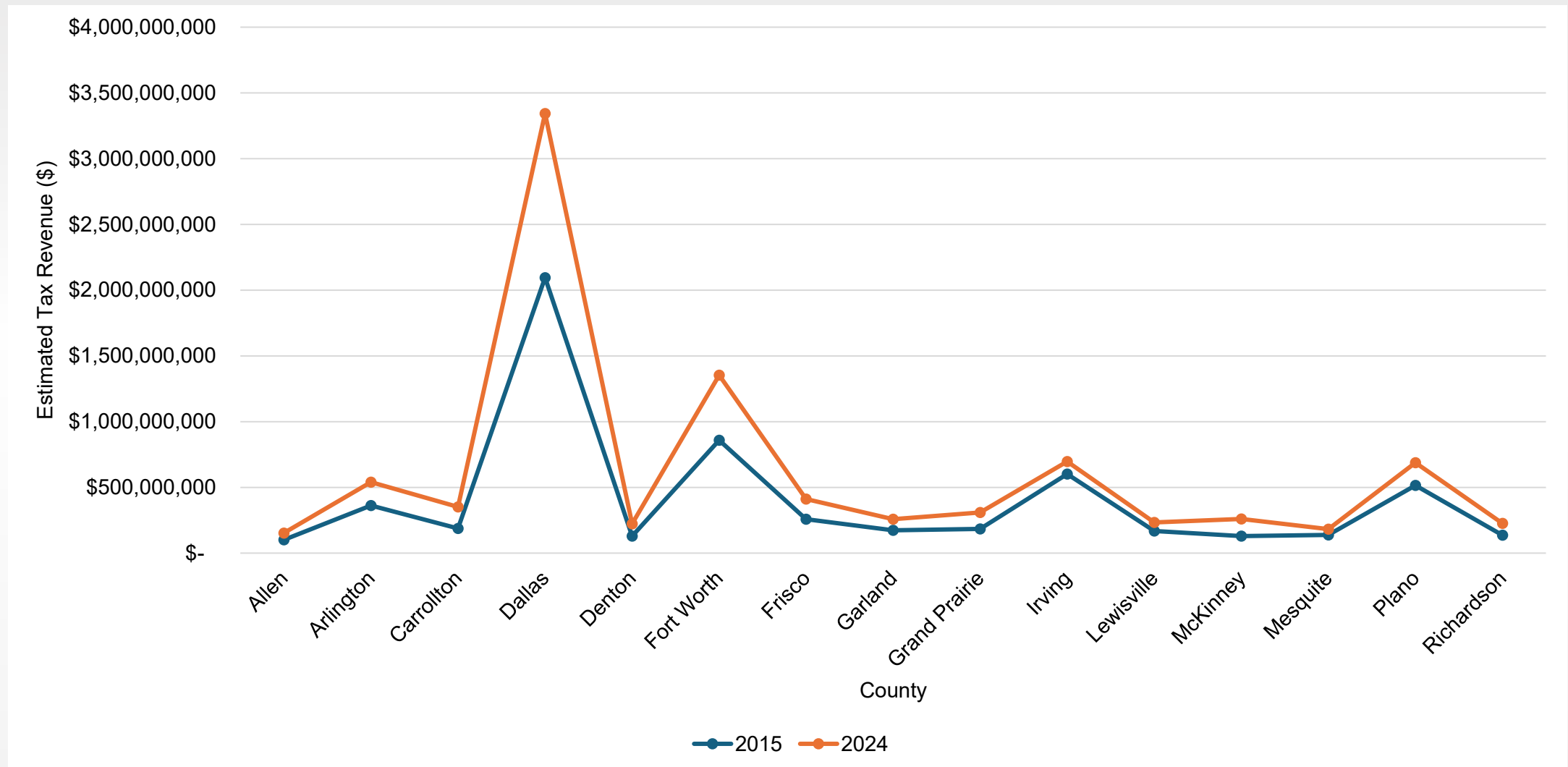
The Texas Comptroller's office collects all sales tax revenue from businesses and then distributes the cities' shares, but not before deducting an administrative fee. This fee means that cities don't get the full amount of tax collected; the final amount they receive is slightly less.

In 2024, the combined sales tax revenue for Dallas, Fort Worth, Irving, Plano, and Arlington exceeded **\$6.5 billion**, including the state's portion. Dallas alone was a major contributor, generating over **\$3.3 billion**, with Fort Worth contributing **\$1.4 billion**.

While counties like Dallas, Tarrant, Collin, and Denton are top producers of taxable sales, they don't charge a sales tax themselves. Analyzing taxable sales by industry shows which sectors are driving this revenue and employment.

In 2024, the retail trade and accommodation and food services industries generated the most taxable sales and employed the most people across Tarrant, Collin, and Denton counties. Dallas County stood out as a leader in retail, wholesale trade, and accommodation and food services, all of which are major contributors to both taxable sales and employment in the region.

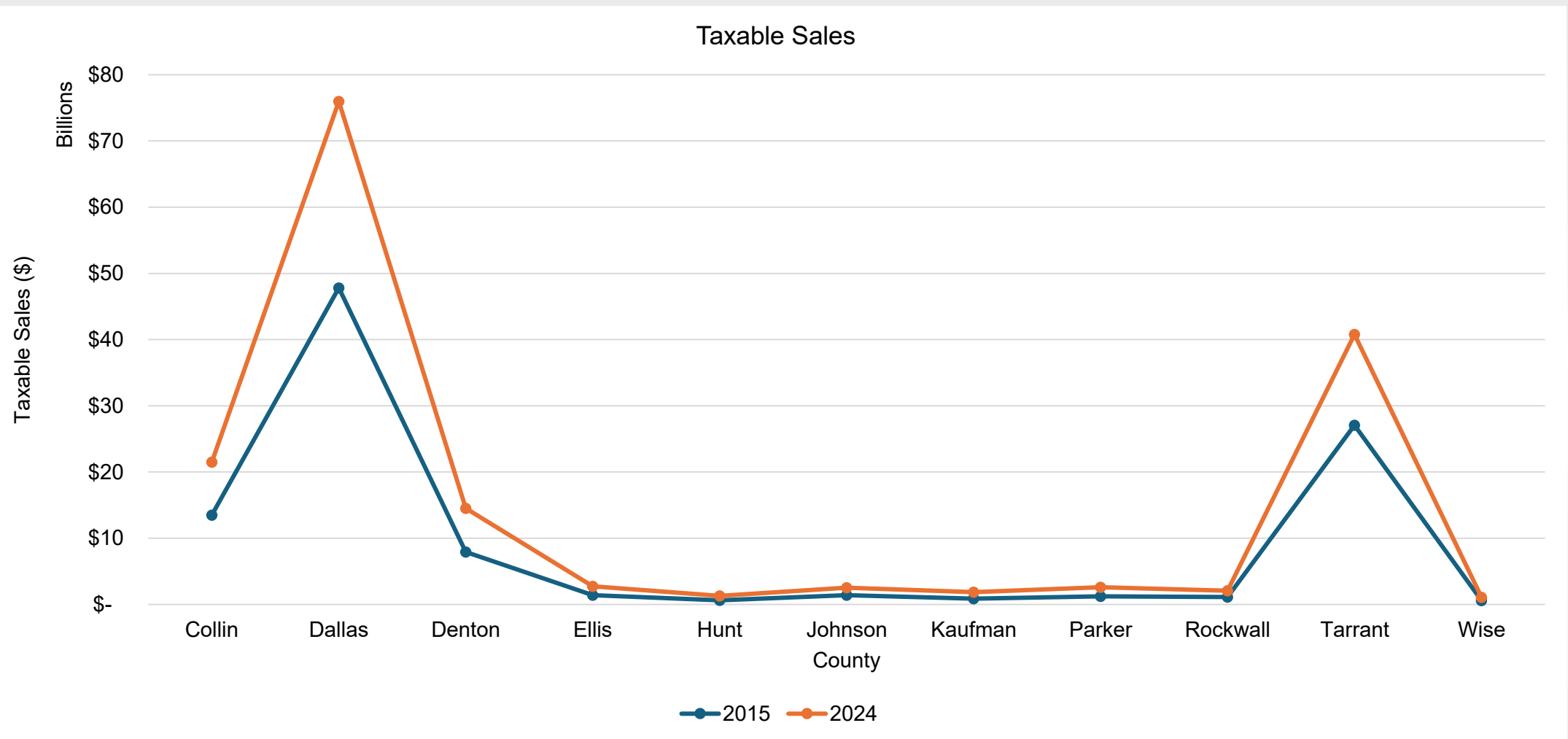
Estimated Tax Revenue by City



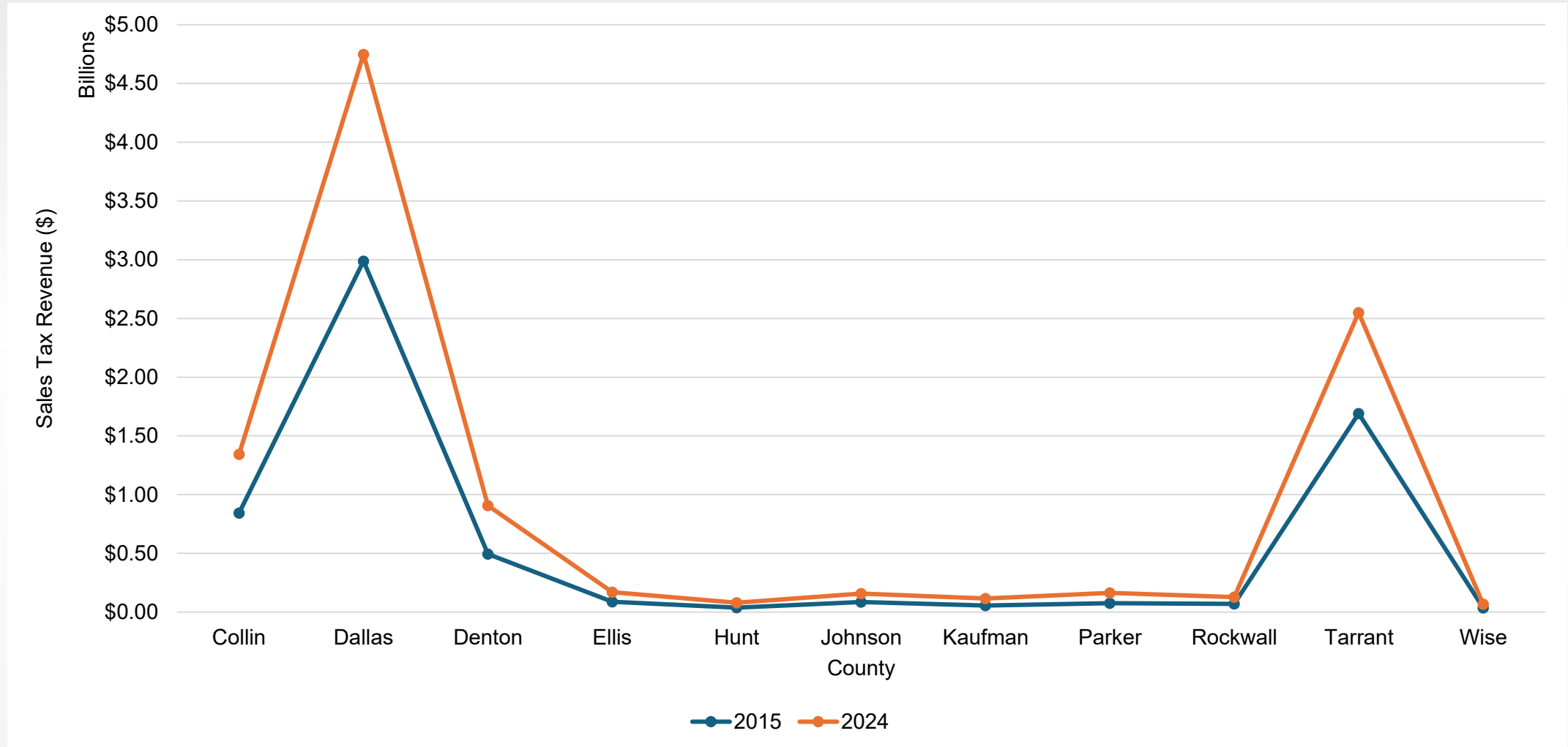
